Motion by Maurice McGleish, supported by Margaret Chapman to remove Bill Avery from the MAWSA Board. Ayes: Margaret Chapman, Gerald Patrick, Maurice McGleish, Sue Robinson. Nays: Dan Bean. Motion carried.

Motion by Gerald Patrick, supported by Margaret Chapman to appoint George Ouvry to the MAWSA Board. Ayes: Margaret Chapman, Gerald Patrick, Maurice McGleish, Sue Robinson. Nays: Dan Bean. Motion carried.

NEW BUSINESS:

- a. Sue Robinson addressed the Board regarding road improvements for 2007. After considerable discussion, a motion was presented by Margaret Chapman, supported by Sue Robinson to approve the following roads: North Limits Road, and one (1) mile of Cedar River Road. Motion carried.
- b. A motion was presented by Margaret Chapman, supported by Dan Bean to hold the next election and elections thereafter at the new township facilities located at 9610 S. M88 Highway. Motion

carried.

- c. A motion was presented by Gerald Patrick, supported by Margaret Chapman to approve the summer tax collection for the school at the rate of \$2.97 per parcel. Motion carried.
